Standard Operating Procedures in view of COVID-19

Pranams from SASTRA SATSANGH & Welcome you to MARGAZHI MELA 2020!

Testing times bring the best out of us and we look forward to the pleasure of partnering with you in the successful conduct of MARGAZHI MELA 2020.

In the interest your safety & the safety of all stakeholders concerned and in full compliance with the competent authorities guidelines on COVID-19 Safety, the following Standard Operating Procedures (SOPs) shall be in vogue for our forthcoming Margazhi Mela 2020-21:

Guidelines for Rasikas / Visitors

- The entry of Rasikas for each concert will be strictly on the basis of online registration passes. Registration can be done at <http://sastrasatsangh.org> 48 Hours prior to the event. Online registration is on a first come first served basis. Registration confirmations shall be sent to registered e-mail/mobile
- Occupancy inside auditorium shall be restricted to a total of 50 Rasikas (hall capacity is 280). Only those carrying proper proof for confirmed online Registration to the event will be permitted inside the auditorium.
- Strictly no entry without mask. All Rasikas / Visitors must wear proper masks covering the nose and mouth at all times.
- Thermal screening of all Rasikas / Visitors will be carried out at the entry point and sanitiser shall also be provided. Only asymptomatic individuals shall be allowed to enter the premises.
- Entry into the auditorium using the backside staircase only. Elevator is only for aged and physically challenged.
- Crowding in common areas such as lobby, wash rooms, parking lot to be strictly avoided.
- Appropriate norm for air conditioning shall be followed by the organisers

- Management reserves the right to identify Rasikas / Visitors not complying with the guidelines and in case of non-cooperation, such person/s shall be asked to leave the venue without any arguments
- Adequate physical distancing to be followed at all times. Every rasika will be guided to sit with a gap of two seats between them. No one will be entertained to sit next to each other in the auditorium. Seating on a first come first served basis and no blocking of seats in anticipation of friends or relatives.
- Rasikas to preferably carry their own Sanitizers to the venue.
- Respiratory etiquettes to be strictly followed. This involves strict practice of covering one's mouth and nose while coughing / sneezing with a tissue / handkerchief / flexed elbow and disposing off used tissues properly.
- Self-monitoring of health by all and reporting any illness experienced at the venue immediately to any Sastra Satsangh staff.
- Entry and exit of the Rasikas from the auditorium and the premises will be restricted. Once the Rasika enter the premises will not be allowed to leave the premises and get back again. Once seated inside the auditorium, kindly minimise your movement.
- Rasikas shall be allowed to exit in a staggered row-wise manner to avoid crowding at any point. The entry and exit will be only through the back door for Rasikas.
- All Rasikas are strictly prohibited from any form of interaction or reaching out to the Artistes before or after the programme. Exchange of pleasantries or any other means of interaction with the artistes are strictly not allowed.
- All Rasikas are requested to enter the premises from 6.30 AM for morning session and 6.00 PM for evening session. We need atleast 30 minutes for pre-concert screening. Kindly cooperate and rasikas are requested to leave the premises ASAP once the programme is over without crowding anywhere inside the premises.
- Rasikas will not be allowed inside the premises once the programme starts inspite of having a valid registration. All are requested to strictly follow the time.
- Kindly note that the gates will be closed by 7 AM for morning session and by 6.30 PM for evening session.

- No four wheeler parking is allowed. Only two-wheeler can be parked within our premises.
- Rasikas are requested to strictly adhere to the above SOPs and cooperate with the management in order to enjoy a safe and secure MARGAZHI MELA.
